This is the first edition of the **Global Recruitment Campaign for 2008**. We have been running this campaign for four years now and in that time we have seen some advances in the number of women appointed to the Court. For example, the Registry overall professional posts are now filled 50 percent by women and 50 percent by men, and two out of three Heads of Division in the Office of the Prosecutor are women. More information about the gender and geographical profile of the ICC, as well as an overview of gender issues in each of the conflict situations where the Court is working, is included in our Gender Report Card 2007 available on our website: <http://www.iccwomen.org>.

Positions currently advertised are listed below. We ask for your ongoing support in identifying experienced women candidates. Please note that the Court prefers applicants from a State Party to the ICC Statute, or from a State that has signed and is engaged in the ratification process.
